The seller will sign the contract and give a copy to the buyer for their records. The seller agrees to furnish the buyer with the necessary health information, including all shots and worming records. AKC registration application will be given to the buyer at time of puppy pick-up. It is the buyer's responsibility to register their new puppy with the AKC.

## **Deposits/Payments**

Deposits are \$500.00 for and amount up to \$5500.00, \$1000.00 deposit for any amount exceeding \$5500.00 and a \$2000.00 deposit for any amount exceeding \$10,000.00 and **ALL DEPOSITS ARE NON-REFUNDABLE.** In the case of a premature death, prior to the delivery of the puppy to you, you can transfer those monies to a future litter of your choice. For any other circumstance your deposit is non-refundable. **IF YOU BACK OUT OR CANNOT PAY FOR YOUR PUPPY, YOU FORFEIT YOUR DEPOSIT.** Pups are chosen in the order the deposits were received. Seller ALWAYS has first choice in all litters. Deposits are to be made in US Postal Money Orders, PayPal, CashApp, Cashier's Check or Bank to Bank wire. Once Blue Moon Kennels has received your deposit the puppy will be marked and considered as sold. **Puppy must be paid for in full by 8 weeks of age.** Buyer agrees to not dispute or request a chargeback of any transactions. ## **Blue Moon's Puppy Guarantee is as Follows:**

1. To be in good physical condition as the time of delivery to the buyer. The buyer agrees to have the puppy examined by a **LICENSED VETERNARIAN within 3 business days, for a complete physical examination.** If the vet finds the puppy to have a serious physical condition other than a bacterial infection, such as coccidia, or giardia, which is easily treated, the seller will replace the puppy with another puppy of comparable quality, when available either from the same litter or a future litter, AFTER, the first puppy has been returned. 2. To be free of any genetic/hereditary defects that cause death or serious impairment of vital functions of the said puppy until **1 YEAR** of age. If such an inheritable defect is documented by the vet and is presented to the seller with sufficient supporting evidence, the buyer will be entitled to a kennel credit up to the purchase price towards a new puppy of your choice, after the first puppy is returned to the seller. **NO REFUND OF ANY MONEY EVEN IF NEW PUP IS LESS VALUE THEN THE KENNEL CREDIT.** Initial\_\_\_\_\_
  
3. Puppy will have up to date vaccinations and worming's. No replacements will be given in case of Parvo. This guarantee **DOES NOT** cover what we consider to be normal problems for the bulldog breed or problems beyond our control such as: **Cherry Eye, Entropion, Loose Hips, or skin allergies such as Mange.** We are not geneticists and cannot predict genetic problems. We do not breed dogs with undesirable conditions such as mange or bad hips, but we cannot guarantee that previous generations from other breeders did not have these conditions in their lines. Therefore, we cannot guarantee that these conditions won't show up. We cannot guarantee that the dog will not contract mange (Red Mange, Demodex Mange or any other mite mange). Mange is a multi-factorial genetic disease that can be transmitted in a recessive manner. There is a great deal of dispute amongst experts as to the differing specific cause of mange including but possible not limited to: Environmental conditions, Stress and Nutrition. **GUARANTEE IS VOID IF THE PUPPY IS NOT EXAMINED BY A LICENSED VETERINARIAN WITHIN 3 BUSINESS DAYS OR IN CASES WHERE THE DOG IS OR WAS INVOLVED IN ILLEGAL ACTIVITY (DOG FIGHTING), OR EXTREME SPORTS (WEIGHT PULLING), OR IS MISTREATED, MALNURISHED, OR ABUSED. VOID IF DOG IS BRED BEFORE 1 YEAR OF AGE. 1. To use "Blue Moon's" as a prefix in the registration of the dog's name.
2. Maintain up-to-date vaccines and keep your dog/pup in humane conditions providing love, proper food, water, shelter and exercise.
3. If you are unable to keep your dog/pup Blue Moon Kennels had the right to reclaim the dog/pup of we will help you in finding the pup/dog a new home.
